- 5. Accounts: DD updated in David Hayhow's absence Trustees annual report 2015 sent to Charity Committee. Bank £6800.00 including £500.00 from Adnams also £250.00 to go in from fete.
- **6. Minutes of meeting Thursday 24th March 2016 :** Item 7. £500.00 from Parish Council and VAT claimed back not included yet in finances. BT sent message that the oil tank ¾ full. RT Forgotten about the bill for paint so he won't be claiming back
- 7. Matters arising: Item 10. Amendment Suffolk Nursery should read Suffolk Norse. RT thought grass cutting finished but it is still in place, invoices are not regular rates gone up from £60 to £70. Adrian Yellop cut the grass last time so that was why only charged for 2 and not 3 visits. Adrian may do regularly, AB will speak to him but if he does do will need some access through hedge off the track. Item 10. Rubbish from loft almost cleared, there are some solvents which shouldn't be there John Dawson will clear with David Hayhow most of rubbish from fete Light Solar light could be put up with a motion sensor John Dawson will sort solar light and fit so electrician not needed.
- **8.** Funding Barge Boards etc DD: SC and DD have quotes for barge boards price range between £5500.00 and £8000.00 including guttering. DD had quote from All Brand to prepare sand down and paint at a cost of £2210.00. Decision to be made to either make do and mend or replace. Gables needed to

- be done first as not been painted since hall built then sides. Della asked if an application to T. Fryatt could be made but DD said already asked for play equipment. DD said Mini lottery budget available and SCDC grant of 30%. Applications to various people for grants and SC will check if quote still stands and apply for funding. DD spoke to Teri re VAT can't get VAT on purchase of play equipment.
- **9. Funding Play equipment :** Swings not classed as sports but have got available money for sports. SC gave costing for 2 Cradle swings to each member and safety matting add £50 to this PC agrees to reclaim VAT on fete money. SC has asked T. Fryatt about locality fund but not heard back so on hold for time being.
- **10. RoSPA's play equipment nspection :** SC sent email costs gone up this year and they can be picky with what they find.
- **11. Blind for Lobby. :** DD Curtains fitted didn't get curtain for lobby and suggested roller blind to keep cost down suggestions were asked about colour to use and agreed to leave decision to DD. DD asked if anyone wanted old curtains DM suggested asking RSPCA for bedding AB suggested Scouts at Grundisburgh
- 12. A.O.B: David Hayhow had asked Della to contact Sleepsafe to repair or replace leaking valves RT asked if water cleared in ditch and AB said a pipe was needed RT will have a look to see what he has. John Dawson said rain water from building makes puddle by door bringing mud into hall and downpipes from gutters not taking water RT believes that it is a soakaway and possible BT would know what drainage it has It was thought a complaint from a hirer could be received if it gets worse. RT said fields had land drains and hedge roots could be blocking drains. SC suggested putting matting in lobby or doormat to cover whole area would help keep cleaner carpet shops usually had stock and these could be cleaned with hoover. Cost of this could be included when applying for grant. SC said is hirer wanted to take curtains down then this should incur a charge. AB asked if campers coning Della advised August 19th and EASC 29th July.
