- There have been some improvements to Road Safety signage around the Manor Road / Shop Road junctions with the B1078, although Road Safety remains a major cause for concern, particularly the expected increase in traffic levels from the proposed use of the B1078 as a feeder route for workers to the Sizewell C construction site.

### CPC APM 008/24 Matters raised by Parishioners

A concern was raised re the No 70 bus service for Clopton being ceased. The SCC consultation document on the Local Transport Plan for 2024 to 2040 promises improved bus services for rural communities, so the cut to Clopton's No 70 service, is completely opposite to the Local Transport Plan! The suggested alternative service for Clopton is to use the Coastal Access system, however, this doesn't serve the area although Clopton is nominally included in the community car arrangement., although However, this relies on volunteer drivers of whom there are very few and it prioritises hospital visits. Councillors shared the resident's feelings, although there was little they could do about it.
