In addition to the report East Suffolk council unlike some other district councils do intend to continue with the collection of the green recycling bins however that is dependent on the work force remaining well.

New recycling instructions will be sent by leaflet as a reminder of what to do with waste.

There will be a 0% Council tax increase this year.

Public Rights of Way

Clopton Commercial Park/Airfield – This is ongoing, suggestions have been sent to the landowner for review. The aim is to restore the historic footpath linkage from Clopton to Debach.

Track to Church - The state of the track that runs from Newson Farm down to the Church was raised as a concern. The actual designated path runs between the two hedges and down to the ford and bridge in what becomes a stream like path. The fields on either side are considerably higher than the track as you get further towards the river. The field on the left side of the track as you travel towards the river has a grassed field margin. This runs parallel to the path, and

has been used by walkers at the kind discretion of the land owner during periods when the actual path has become difficult to walk.

Unfortunately due to it's use by horse riders, this field margin has suffered severe damage over winter, and is now very cut up and practically unusable for walkers.

The land owner is unhappy about this damage. Whilst he is sympathetic to use of the field margin by walkers and is attempting to resolve the situation with those concerned, if it is not resolved he would like to inform the village via the parish council that with regret, he will be forced to restrict the natural access to this grass track for all users.

Please note that this is for information only, this is not a Parish Council matter as is on private land and is not in the remit of the Parish Council for resolution.

As a reminder the Parish Council cannot become involved in any private issues.

To approve 2020/21 Parish Council budget.

A draft budget has been circulated for consideration at this meeting. This allows for a small percentage increase in the usual annual payments it also includes a payment of £180 to go into a new earmarked fund for Village Hall expenses, this has been set up as a fund to save for the next lease renewal in 2045 and as a buffer for any unexpected costs associated with the Village Hall.

The budget draft allows for £4750 expenditure

To set 2020/21 Parish Council Precept

CPC understand that it has been an unusually difficult time financially for residents and therefore do not wish to increase the precept from last year's amount of £4500. Although the budget is set for a higher amount any difference will be taken from the general reserves.

East Suffolk Council have allocated one off grants to reduce the amount of precept that parish councils have to ask from tax payers, for CPC that grant is £61. As such CPC will be applying for a precept payment of £4439

Assign new payroll supplier

Ladywell Accountancy are going to cease trading at the end of March. The Clerk has sought out new suppliers and has found SALC to be the only local supplier who is remotely comparable cost wise. SALC can offer bi monthly payslip production in line with the number of meetings that we have for £45 plus VAT. If we were to have monthly payslips as we currently do the price would be £90 plus VAT. As the Clerk is paid by cheque following the bi monthly meetings it has been decided that bi monthly payslips are adequate and SALC will be asked to take over patrol following the March year end.
