The Clerk has alerted this to our internal auditor in preparation for the next audit. The Clerk will make a VAT claim minus the Zoom VAT element.

- Bank reconciliation check Cllr. Pitt has checked and approved the bank reconciliation in advance of the meeting.
- Initial consideration of 2021/22 Parish Council budget.

It is estimated that we will be over budget by between £700 and £800

This is due to the Birketts solicitor's invoice of £1606 for the lease falling into this financial year. As discussed in previous meetings we had not budgeted for the expenses associated with the new lease for the village hall. This amount is being taken from the general reserves.

We anticipate however to be under budget on a number of items to the tune of around £450 and the VAT claim will include the VAT on the Birketts invoice which increases the VAT claim by £320.

A draft budget has been circulated for consideration at this meeting. This allows for a small percentage increase in the usual annual payments it also includes a payment of £180 to go into a new earmarked fund for Village Hall expenses this has been set up as a fund to save for the next lease renewal in 2045 and as a buffer for any unexpected costs associated with the Village Hall.

£313.85 from General reserves are to allocated for the Jubilee celebrations and the existing earmarked fund for future fetes of £186.18 will be available also for this event.

The budget draft allows for £4777 expenditure

Budget needs to be finalised at January meeting and the precept will be set at the January meeting.

CPC104/21 B1078/9 Speed issues The Chairman and Clerk have met with Cllr Bryce who is supportive of the attempt to obtain a speed limit for Clopton Corner which encompasses the Shop Road and Manor Road junctions onto the B1078. Information from SCC Highways is such that currently the junction does not meet the criteria for a speed limit, however SCC Highways are now suggesting that it may be beneficial to repaint the slow markings on the road and increase signage to show that it is a hazardous section of road. The East Suffolk Council Community partnerships is focusing on road safety and there are grants available. Any traffic calming measures will have to be funded via the parish council therefore we have asked Cllr. Bryce to gain a cost associated with the above measures so that we can hopefully apply for a grant.

CPC105/21 B1078/9 Speed issues SCC are carrying out a lorry route review and have asked parish councils to report to them up to 3 sections of roads on which lorries cause issues. The Clerk has circulated an email asking for resident's feedback and has received responses outlining 3 areas of concern.	Clerk/ Chairman
Drabbs Lane - This is supposed to be the exit route for Debach Airfield traffic to the A12 at Woodbridge. There is a weight restriction on northbound lorries however this has been observed to be ignored several times a day. The size and weight of the Lorries is cause damage to the road and verges.	
B1079 full stretch throughout the village – A number of residents have reported a serious problem with HGV Lorries at points of this road through the village. The road width is inadequate in places meaning that when two large vehicles meet along sections of this stretch of road one has to reverse back down the main road where visibility is seriously restricted by bends. This is an issue that occurs multiple times every day, day or night.	

This road is a danger to pedestrians and cyclists as there no space to get out of the way of a large vehicle. There is constant damage to the verges, curbs and drainage. The weight has damaged the road surface. B1078 Clopton corner Large HGVs pass along this section of road more than 10 times a day (often many more, probably 50) The main issue is road safety to pedestrians and other road users and intimidation of these other users. Some of the pedestrian users are school children using the bus stops at this location. This problem is acute at the end of the school day when children alight on the south side of the road and mostly have to cross to the north side where they live. The intimidation is also for drivers emerging from the very poorly sighted Shop Road and Manor Road junctions. Allied issues are damage to the road surface, damage to verges caused by over-running when large vehicles have to pass and poor air quality. The traffic is present over extended working days, typically 6am to 9pm, mainly on weekdays. Many of the large HGVs using this section of road are clearly not adhering to the prescribed lorry route for the Debach airfield site which can be characterised as "in from the A12 via Bredfield, out via Drabbs Lane and Grundisburgh". CPC will complete the SCC survey and gain endorsement as required from Cllr. Bryce before submitting these responses. CPC106/21 Village Hall Lease Renewal The lease has been exchanged and completed.
