SCDC Report The partnership with Waveney is proving very successful & all Directors cover both District Councils. This saves £45,000 per year. The Local Development Framework is still ongoing. Central Government funding is down by 28% & SCDC are making savings of £2.1m this year and £2-3m over the next two years. The costs for running SCDC are not much higher than 10 years ago which is excellent. There is no increase in Council Tax this year. The Planning Department was heavily criticized for its dealings with communication and Enforcement. It will implement most of the recommendations of the Scrutiny Committee. SORR was very much involved in bringing the problems to the fore. The Environment Agency had to make a U-turn over funding for sea-defences at Felixstowe and £10m has been allocated. The three bin recycling scheme is now complete and 60% of waste is recycled. Some problems with fly-tipping are increasing.

Mr. Dawson felt the analysis of the Parish Plan should be available to all. The Clerk will provide a copy for the village and one for the Local Historian. Any ideas on taking the plan forward should go to Cllr. Angwin.
