CLOPTON PARISH COUNCIL

Minutes of the Parish Council Meeting held at 7.30pm on 15th. March 2012 in the Village Hall

Present: Councillors R Compton (Chairman) S. Freeman, L. Pennington & C. Angwin & the Clerk, G. Kimmerling

In attendance SCC Cllr. Bellfield, Anna Elmon, Communications Manager, Gressingham Foods and 11 members of the public.

The meeting commenced in Open Session.

The Chairman welcomed Anna Elmon and invited her to give a report.

Ms Elmon explained that the main complaints about Gressingham Foods are speeding drivers and lorries taking the wrong routes. Measures to combat these problems are:- all drivers who use the site are issued a Driving Information sheet (in English, Lithuanian, Polish & Romanian); an emphasis on speeding restrictions; maps showing the villages affected & an agreed slight change of route. The website has a map showing the routes & the correct post code for sat. Nav. The Company handbook has information on misconduct & gross misconduct re speeding. It is also proposed that all company drivers have a card in their windscreen as identification.

Questions and comments.

It was suggested that Ms. Elmon tries out the routes as the HGVs take up all the road in some places. Some lorries have been stopped because they were going the wrong way and they had missed the return route on the instructions.

The County Council route takes HGVs down Drabbs Lane so none should drive further along the B1078 through Clopton but they do. This is because it is much shorter to cut through to the A14. Lorries going to Redgrave cut across country to Coddenham – this is not the correct route. Lorries carrying live ducks take short cuts as there is a time limit on how long they can be transported. It appears that the volume of traffic has greatly increased. Ms Elmon said the site has not expanded and there are no plans to expand. She was not aware that any land had been purchased here. It was felt that the site had doubled in size in the last 6 years.

A lot of lorries visit the site at night and the lights are on all night. Other issues causing concern are; light pollution; smells at night when the lagoons are pumped out; noise from the new fans, day & night. The cost of road repairs in Looms Lane came to £175,000 – the roads are not suitable for the volume and size of traffic.

Speedwatch carry out speed surveys & it was suggested that someone from Gressingham Foods should join in.

There is a lot of litter in Looms Lane – fast food cartons etc. More litter-picks by Gressingham Foods would help.

Cllr. Compton summed up the discussion:-

- 1) Gressingham Fooods to take part in the Speedwatch surveys
- 2) Ms. Elmon to attend a meeting in May (possibly APM) to discuss other issues
- 3) Gressingham Foods to have regular meetings with residents 4 to 6 monthly
- 4) Gressingham Foods to have regular contact with the Clerk regarding local issues.

Ms. Elmon and 10 members of the public left the meeting.

SCC Cllr. Bellfield gave a report from SCC – SCC will have saved over £42m in the last financial year & 1400 members of staff have left. It has to save £26m in the next two years. The Council tax will remain the same for 2012/13. SCC own 2500 properties in Suffolk and are planning to rationalise these. The Police & SCC are moving into Landmark House in Ipswich. Almost all the county parks have been taken over by Town & Parish Councils. Businesses are urged to register on the County website re Broadband by the end of March.

SCDC – no change to the Council tax. The partnership with Waveney is progressing well. SCDC have to save £2.1m this year.

Cllr. Compton said that 22.5 thousand businesses have not registered for Broadband. More people need to register to get faster Broadband.

The Clerk read out the Police report from P.C. Burrell-included in the Minutes folder.

The Open Session concluded at 8.25 and the Parish Council meeting commenced.
